Code of Conduct Agreement

In an effort to make our collective experience a safe, fun and memorable one, it is important that we all agree to a minimum set of expectations concerning all students' behavior while the group is traveling together.

1. Students must follow all school and district policies and procedures as outlined in the Student Rights and Responsibilities Handbook and the MRHS Student/Parent Handbook. All school/ district rules will be enforced during the trip, including, but not limited to, the following:

A. No possession, or use, of illegal substances will be tolerated.

B. No sexual conduct, contact, indecency or displays of affection will be tolerated.

C. All medication, even over-the-counter medicine, will be kept in the possession of the chaperones, and dispensed by them.

2. Students are not permitted in any dorm/hotel room other than their own. No exceptions.

3. Couples will not be permitted to room together.

4. All curfew and room check times will be honored and strictly adhered to.

5. All students will be on time for all scheduled activities, and will attend all activities unless otherwise specified or arranged with the Director.

6. Students will be in groups of at least 3-4 at all times. All transportation is via school bus, charter or school van.

7. All students will follow the instructions given by any staff member or chaperone.

8. All dorm/hotel rooms will be kept as tidy as possible during our stay, and are subject to random inspection by the Director, staff or chaperones.

9. Any damage to a dorm/hotel room will be the shared financial responsibility of all persons assigned to that room. Any damage to any other facility, instrument, equipment, etc will be the responsibility of the person responsible.

10. On the van or bus, no yelling. Use earbuds or headphones so your music will only be heard by you. Keep all trash picked up.

11. All students are subject to search (with MRHS Administration oversight) if there is reasonable suspicion that they are in possession of any type of contraband as outlined in the DVUSD Student Rights & Responsibilities Handbook.

Consequences

Band consequences for any inappropriate behavior can range from loss of privileges, to exclusion from group events, to exclusion from performances.

In addition to band consequences, parents may be required to come pick up their student immediately at their own expense. There may also be an Office Referral to MRHS Administration upon return from the trip for further discipline.

It is also understood that there will be no refunds for any portion of the costs associated with any of the activities missed as a result of inappropriate behavior.
